# We've Got "It"

In the latest issue of *UU World* magazine, UUA president Peter Morales writes about the "it" church. His article begins:

Some congregations have it. Others don't. And it doesn't take long to figure out if a congregation has "it" or not. We sense it right away. It is unmistakable. Some congregations are full of life. The energy fills the room. The warmth is palpable. We feel it in worship. We sense it in coffee hour. There is something about the "buzz." We see people smile and embrace. They engage one another.

Sound familiar? We all know he is talking about us. Recently I told a seasoned colleague that many people cry during our worship services. He shook his head a bit and asked, "Why?" I was surprised. I looked him in the eye and said, "I believe they feel safe and moved. They are relieved to feel at home at last, and so the tears flow." This is the congregation that you have created by your welcoming spirits and warm reception. Right at the top of my list of priorities for a faith community is safety and inclusiveness. Human beings hunger for these basic needs. You've done it, and we've got "it."

Morales continues:

What makes the difference between being full of life and warmth versus being dead and cold? I think the difference is religion. Really. Religion . . . We tend to think of religion as a set of beliefs. That is a huge mistake. Religion is much more about what we love than about what we think.

Sound familiar again? I thought so. At UUCSC we have found that it is insufficient to engage in purely intellectual deliberations. We do well to engage our hearts as well as our minds along the faith journey. Faith is a meaning-making experience, done best where it is safe to feel, to explore and yes, to cry. We've got "it."

We are a community of human beings; difficulties will arise here. We've had our share. We can handle difficulties—we've proven that. Openness, transparency and good faith are part of the "it" we've got, and we'll need them. In the near future we will address several issues that can be controversial. I will mention three:

- The probability of having two worship services can raise strong differences of opinion.
- On May 2nd, worship concerns addiction. We'll begin to look at how that issue might impact our decision whether to serve alcohol in our building.
- The May 23 worship service explores the transgender life, a topic still challenging for many among us.

At UUCSC we do not avoid controversial and challenging issues. We shine the light on these questions, knowing we can communicate and work through our differences. We can do it. We've got good faith. After all, we've got "it!"

#### Four weeks seems like a long time

What happens at a choir rehearsal? How does that music come together? Why are there so many notes?

You may think this was a listing of questions that members of the congregation ask themselves, and if your mind did wander in that direction, you would be mildly correct. It's also what goes through my head on a weekly basis.

There's already so much to consider when learning a piece of music by oneself. There are, of course, the notes, but then many variables come into play. There are dynamics (how loud or soft), articulations (how to attack the notes, i.e., short and light, strong and heavy, smoothly connected, etc.), questions of tempo (how fast is too fast /slow?), and the issue of rhythmic precision. It seems like enough to contend with by itself, but then we must add to the mix, in the case of an ensemble like the UUCSC Choir, that there are many people performing the same piece. How then do we reconcile many peoples' views of the same piece of music to create a coherent final

#### product?

Again, welcome to my head before Thursday rehearsals.

Luckily for me, the Choir here at UUCSC is indeed a hardworking one, and its members' receptiveness to a group learning process makes it possible to sing new pieces and anthems each week. We have decided to share a rehearsal of ours with the congregation at large, opening it up to anyone who would like to come sing with us for a rehearsal, to see what it is we do, and how the process of making music as one group manifests itself on a weekly basis.

Even if you consider yourself only a "shower singer" with no knowledge of reading music, know that you are not alone in your habits of crooning cleanliness, and you are most welcome to join us.

The special rehearsal will take place after the service on Sunday, May 16 from 11:30 a.m. to 1:00 p.m. All are welcome, no need to respond in advance. Hope to see you May 16 after Coffee Hour!

# MONEY MATTERS

The monthly column from the Finance Committee

Q. So how are we doing on our Pledge returns for 2010-2011?

A. We have been receiving the pledge cards at a slow rate but, so far, the results are very encouraging. Laying out our financial picture at our Sunday service in March has brought our pledged amounts up. We are cautiously optimistic that this trend upward will continue as we move into the final phase of returns.

Q. So how are we keeping up with expenses in our new facility?

A. Although we are working with a \$17,000 budget deficit, we have had enough money to keep up with expenses to date. One possible plan at fiscal year end is to "borrow" from our Land and Building fund to close what deficit remains at that time. That will lower our reserves, but we may be able to repay the "loan" early in our next fiscal year. We have a few new fundraisers in the works that we hope will generate fun, enthusiasm and additional income. As we had anticipated, we have been blessed with a number of new people joining us each Sunday. Their generous donations have noticeably increased our income.

#### Q. How can I learn more about what is planned for next year?

A. The Finance Committee will meet on May 12 at 7 p.m. in the Community Room to finalize the proposed budget for fiscal year 2010-2011. We would love to have anyone who wished to attend join us. When the proposed budget leaves our Committee, it is submitted to the Board for their review. The final version will be voted on at our Annual Meeting in June.

# "Norma Rae"

Let us celebrate the heroic life of the real "Norma Rae," Crystal Lee Sutton, who stood up to fight corporate greed and bring justice to textile workers, on Tuesday, May 25 at 7 p.m. in the Sanctuary.

Scott Molloy, professor of labor and industrial relations at URI, will facilitate our discussion of the 1979 film starring Sally Field as Norma Rae, a minimum- wage worker in a cotton mill who decides to join the effort to unionize her shop.

The real Norma Rae gained fame during the early 1970s after she was

fired from her job at the J.P. Stevens plant in Roanoke Rapids, North Carolina for trying to unionize its employees. She was earning \$2.65 an hour folding towels. The



poor working conditions she and her fellow employees suffered compelled her to join forces with Eli Zivkovich, a union organizer, and attempt to unionize the J.P. Stevens employees.

She finally was fired. But before she left, she took one final stand, shown in the film as it actually happened in real life "I took a piece of cardboard and wrote the word UNION on it in big letters, got up on my work table, and slowly turned it around. The workers started cutting their machines off and giving me the victory sign. All of a sudden the plant was very quiet...". Police physically removed her from the factory.

In a subsequent election, the Amalgamated Clothing and Textile Workers Union won the right to represent the workers at the plant.

Early bird Oh, if you're a bird, be an early bird And catch the worm for your breakfast plate. If you're a bird, be an early bird— But if you're a worm, sleep late.

Okay kids, here is a secret that I have . . . I sleep late ALL THE TIME!

Now please do not confuse this with oversleeping. Oversleeping implies that one has slept too much (say what?) or, at the very least, that one has become very late due to sleeping away the time. Perhaps one has not taken the time to learn how to set the alarm on the alarm clock. Oversleeping is a mistake, an unfortunate event and has consequences.

Now sleeping late . . . herein lies an art form. Make no mistake, there is even a science to it. So let's use the Scientific Process:

# Contra Dance on May 15th!

The Second Annual South County Open Band Contra Dance will happen on Saturday, May 15 from 7:30 to 10:30 p.m. in the Sanctuary. Lucia Watson, an experienced dance caller, will teach and call the dances. A group of amateur and professional musicians from around the state will provide live music.

Contra dance is a highly social form of early American folk dance in which partners change frequently. It is said about a contra dance that by the end of the evening, you will have danced with everyone in the room! No special attire is required (although lightweight clothing is recommended since things will heat up). Please wear clean, non-marking shoes to protect our beautiful wood floor.

Almost all ages can learn to contra dance. No partner is required, and no special dance skill or background is needed. All dances will be taught.



Contra dance music comes from many traditions: Celtic, Quebecois, Appalachian old time, and these days, even jazz and klezmer. Almost all contra dances feature live music. Fiddle playing is usually prominent.

Music for this dance will be provided by the South County Old Time Music Jam Session. This group used to meet in the American Legion Hall on Monday nights, and has played at a couple of UUCSC auctions. We have received support for this dance from two wonderful organizations. The Rhode Island State Council on the Arts provides funds for a series of

music workshop/jam sessions that take place at the Kingston Free Library on second and fourth Monday evenings of each month. Musicians participating in these workshops will play the music for the dance. The Country Dance and Song Society (www.cdss.org) provided additional funds to insure that we will have seasoned professionals playing along with the volunteer musicians at this dance.

Our contra dance last year was a wonderful community event, with about 70 dancers in attendance. We hope to keep this tradition going.

### A brief history of Unitarian Universalist involvement in and support of bisexual, gay, lesbian, and transgender issues

**1967** March – Unitarian Universalist Committee on Goals publishes results of its survey on beliefs and attitudes within the denomination: 7.7% of UUs believe that homosexuality should be discouraged by law; 80.2% that it should be discouraged by education, not law; 12% that it should not be discouraged by law or education; 0.1% that it should be encouraged.

**1969** September – LaForet, Colorado – Rev. James L. Stoll publicly declares himself to be homosexual at Student Religious Liberals (SRL) Conference.

**1970** July – General Assembly General Resolution to end Discrimination against Homosexuals and Bisexuals.

**1971** June – Rev. Richard Nash and Elgin Blair co-found UU Gay Caucus (which later becomes Interweave Continental) to lobby for the creation of an Office of Gay Affairs.

**1973** June – General Assembly General Resolution to Create an Office of Gay Affairs that will be staffed by gay people and be a resource to the Unitarian Universalist Association.

**1979** – Rev. Douglas Morgan Strong called to serve All Souls Church, Augusta, Maine, thus becoming the first out gay man in the UU ministry to be called to serve a congregation.

**1979** – Gay and Lesbian Affirmed (GALA) founded by Rev. Robert Wheatley and cosponsored by the Office of Gay Concerns and Ferry Beach Park Association.

**1984** June – General Assembly Business Resolution affirming the practice of UUA clergy performing Services of Union between same-gender couples.

**1986** – UUA adds non-discrimination clause for employees who are HIV-positive to Personnel Manual.

**1992** June – UUA Board of Trustees resolution expressing disapproval of the Boy Scouts of America's policy of discrimination against gay and atheist scouts and leaders.

**1993** April 25 – UUA endorses the March on Washington for Lesbian, Gay, and Bisexual Equal Rights and Liberation. UUA Board of Trustees adjourns its quarterly Boston meeting to reconvene in Washington, D.C., and attend the March.

**1993** June – General Assembly stages public protest against North Carolina's "crime against nature" laws. As required by GA 1987 resolution, UUA Board, staff, members, and GA delegates participated in candlelight vigil and witnessing.

**1994** June – General Assembly Resolution of Immediate Witness regarding Sexuality Education in Public Schools.

**1996** – UUA Board of Trustees passes resolution in support of Same-Gender Marriage.

**1996** April – Office name changes to Office of Bisexual, Gay, Lesbian and Transgender Concerns (OBGLTC) to reflect commitment to the transgender community.

**1996** June – General Assembly Resolution of Immediate Witness in Support of the Right to Marry for Same-Sex Couples.

**1999** June – General Assembly Action of Immediate Witness to Work to Change Discriminatory Policies of Boy Scouts of America.

**2000** June – 25% of all UUA congregations are Welcoming Congregations.

**2000** June – Liberal Religious Educators Association (LREDA) becomes first Welcoming Organization.

**2002** May 12 – Rev. Sean Parker Dennison called to serve South Valley UU congregation of Salt Lake City, Utah, thus becoming the first out transgender person in the UU ministry to be called to serve a congregation as a parish minister.

**2002** May 19 – Rev. Laurie J. Auffant called to serve Follen Church Society of Lexington, Mass., thus becoming the first out transgender person in the UU ministry to be called to serve a congregation as a minister of religious education.

**2004** February – UUA President's Freedom to Marry Fund is launched.

**2004** May 17 – UUA President Rev. William G. Sinkford legally marries Hillary and Julie Goodridge, lead plaintiffs in *Goodridge v. Massachusetts Department of Public Health* in Eliot Hall at the Unitarian Universalist Association.

**2006** June – 50% of all UUA congregations in the United States are Welcoming Congregations.

**2008** March – UUA Committee on Socially Responsible Investing files stockholder resolution with Wal-Mart to prohibit discrimination in employment based on gender identity (PDF).

**2010** April – 650 UUA congregations in the United States are Welcoming Congregations.
